

PRIVACY POLICY

This Policy describes how The Financial Core LLC and its affiliates (collectively "FC") treat personal information that FC collects and receives from you. Personal information includes information about you, such as your name, address, e-mail address, phone and social security numbers, and financial information, that is not otherwise publicly available. This Policy does not apply to the practices of companies that FC does not own or control, or to people that FC does not employ or manage.

Information Collection and Use

FC will not use or share the personal information provided to us online in ways unrelated to those described above without also providing an opportunity to opt-out or otherwise prohibit such unrelated uses.

Other Disclosures

FC may store and disclose personal information as allowed or required by applicable law and may perform disclosures that are necessary or advisable to: (a) protect the rights, safety or property of FC or others, or (b) conform to legal or regulatory requirements.
